Fund Objective

To outperform the MSCI World Small Cap Index \$A on an annual basis and to outperform the same index by 2% to 3% p.a. over a full market cycle (e.g. 5 - 7 years).

Fund Manager

Copper Rock Capital Partners LLC ("Copper Rock"), based in Boston, MA, was founded in 2005 and provides specialised global equity investment management solutions for investors throughout the world with a strong focus on small cap investing globally. Copper Rock had approximately \$6.4 billion (USD) in assets under management as at 31 December 2017.

Investment Philosophy and Approach

Copper Rock believes that small and mid-cap markets are inefficient and uses a blend of quantitative and fundamental analyses to identify companies with superior growth rates relative to their peers. The Global Small Cap strategy typically looks for resilient and defensible business models that are characterized by underlying unit growth, longer term market share gains (an evidence of competitive strength), high profitability, and significant internal cash generation. Distinguishing elements of the process are also the application of a routinely practiced and proven Sell Discipline and Alert List that provide risk control and are crucial in preserving alpha earned in the portfolio.

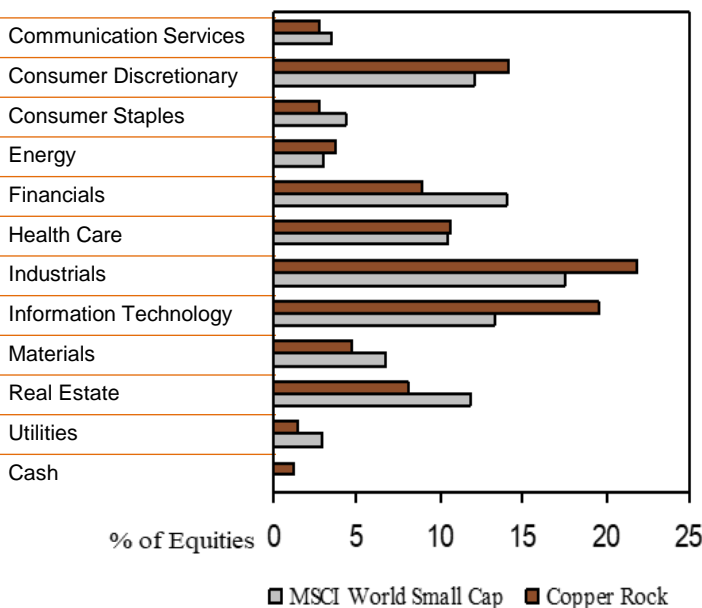

Market Commentary

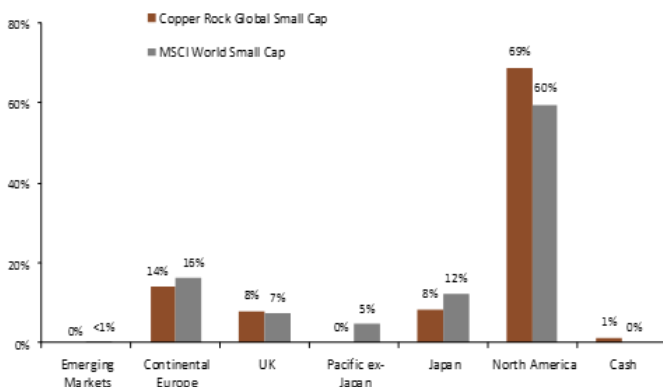
The Copper Rock Global Small Composite posted a return of +0.88% (AUD) vs. +2.11% (AUD) for the MSCI World Small Cap index in the month of January. Although trade tensions had eased following the announcement of the Phase 1 US-China trade deal, markets fell sharply negatively as the month wore on due to the Coronavirus. Our portfolio was not immune.

Stock selection in the Information Technology, Healthcare, and Energy sectors contributed to relative return. There was also positive contribution from stock selection in Japan and the UK. Some of the individual stocks that had been added in the 2nd half of 2019 lagged amidst the market volatility and sentiment.

Mimecast, Ltd., an email and data security company, was a leading contributor in the period. The company announced the acquisition of Segasec, which provides digital threat protection, and to strengthen Mimecast's clients' cyber defense. The stock price reacted positively to the news.

Sky West, Inc. is a holding company for SkyWest Airlines, a US based commercial airline carrier and aircraft leasing company. In January, the stock took a pause on concerns of the coronavirus outbreak and implications on the travel & leisure industry. Despite these fears, the company reported strong 4th quarter earnings from a new 10-year contract with American Airlines. Copper Rock continue to own the position.

Copper Rock are excited about the prospects for the Global Small Caps on the basis that earnings momentum is improving and inflecting positively. Troughing of economic data and improvement in macro economic statistics (e.g. PMIs, ISMs) is supportive of robust earnings recovery and should be fuel for outperformance. Copper Rock have added exposure to cyclical sectors where Copper Rock are seeing signs of inflecting earnings momentum.
